Compulsory return to the base at 17:00 the evening before disembarkation.

Charter less than 1 or 2 weeks possible, upon request and subject to the period

### 2024 GENERAL TERMS & CONDITIONS

#### INCLUDED IN THE PRICE

VAT, yacht equipment & insurance, dinghy with outboard engine, gas bottle, linen

#### NOT INCLUDED:

- **Compulsory** End Cleaning: 50€ per cabin for monohulls up to 52ft, for 52ft and over cost is 250€. 300€ for catamarans.  
Fuel, water, Transfers, Food provisioning, Beach towels, Water toys or any other optional extras, such as Hotel Reservations, Wi-Fi, Car Rental, Flight /Ferry Tickets etc, etc are not included and be arranged upon request. outboard €80

Crew gratuities are not included in the rate.

#### PAYMENT TERMS

Upon receipt of Booking Confirmation, we will issue Charter Contract and send you the Invoice accordingly.

**Within 5 days** from the date of confirmation we require advance payment of 50% of charter cost plus \$500, otherwise booking will be cancelled automatically.

**45 Days before** departure we require **full payment** along with crew list



## SAILING LICENSE REQUIREMENT

For bareboat charter, one sailing license is compulsory. The licenses must be in the English language. The Croatian skipper sailing license Category B, Day skipper license is not accepted by Greek authorities. If clients hold a RYA Day Skipper, they need to apply for an ICC certificate.

## SECURITY DEPOSIT

Depending on yacht size, payable via Visa, Master upon embarkation.

### **REFUNDABLE DEPOSIT:**

**Monohulls: 30 - 42 ft:** €2.000 / **43 - 48 ft:** €2.500 / **49 - 52 ft:** €3.000 / **over 53 ft:** €4.000

**Catamarans: up to 43 ft:** €3.000 / **43ft-48ft:** €4.000 / **over 48ft:** €6.000

**Motor Yachts:** 3.000 - 4.000€ depending on the size

**Refundable Guarantee Deposit** is payable via credit card upon embarkation as per contract.

VISA CARD and MASTERCARD are accepted in all bases. Guarantee Deposit is also required, even if a skipper is hired at extra cost.

## CANCELLATION POLICY:

Cancellation fees are calculated depending on the period of time between the date of cancellation and the departure date as follows:

- **More than 60 days** before embarkation, 30% to the total charter amount+\$500 Handling fee
- **Between 60-30 days** before embarkation, 50% to the total charter amount+\$500 Handling fee
- **Less than 30 days** before embarkation, 100% to the total charter amount. No refund

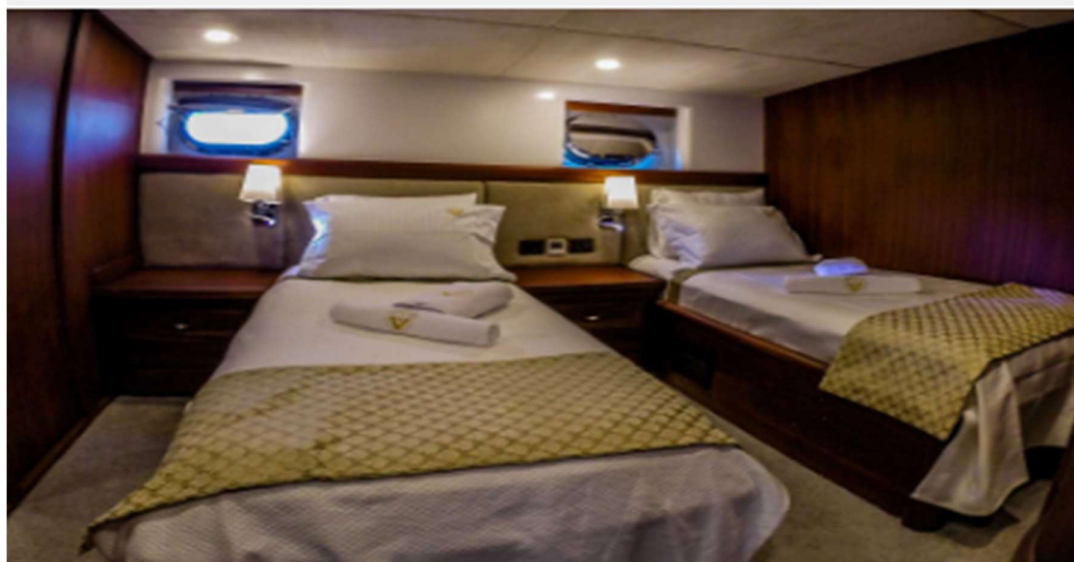

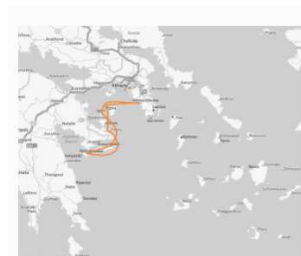


## Suggested Itineraries & Destinations

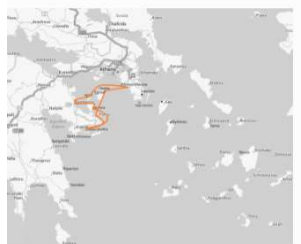

These changes may affect prices, duration of tours, itineraries, contents, etc. Information contained in the brochure has been carefully checked and to the best of our knowledge is correct at the time of publishing. Prices and conditions of travel are subject to change without notice.

## VALIDITY:

Brochure is valid 1 January 2024 to 31 October 2024, unless dates under individual land components state otherwise.

## HOW TO BOOK:

Contact your Travel Agent or Greece and Mediterranean Travel Centre Pty Ltd to make your reservations.

A booking request is accepted when we issue a written booking confirmation. It is at this point that a contract between us and you comes into existence subject to these Booking Conditions. We reserve the right to decline any booking at our discretion. No employee of ours other than a director has the authority to vary or omit any of these Booking Conditions or to promise any discount, refund or credit.

Confirmed bookings will be issued with an invoice upon confirmation detailing all services booked. It is your responsibility to ensure all details are correct. The right is reserved to correct any errors in rates quoted or calculated for any service notwithstanding that the invoice may have been paid in full.

## SERVICES

The services we provide to you are limited to (a) the arrangement and coordination of your travel arrangements; and (b) the delivery of travel arrangements which we directly control. This includes (often significant) work undertaken prior to travel to arrange and coordinate the delivery of your travel arrangements.

## PRICES & EXCLUSIONS

Prices stated are in Australian Dollars (\$AUD) and are current at the time of publication unless otherwise indicated. We also sometimes invoice in Euro or New Zealand dollars. International and domestic airfares and airport/hotel transfers are not included unless specifically stated. We will not be responsible for any other loss or loss you incur in connection with your booking (for example, airfares and visa expenses) if you are prevented from commencing or continuing your trip in these circumstances.

### CANCELLATIONS OR RESCHEDULING BY US

In these Booking Conditions, the term Force Majeure means an event or events beyond our control and which we could not have reasonably prevented, and includes but is not limited to: (a) natural disasters (including not limited to flooding, fire, earthquake, landslide, volcanic eruption), adverse weather conditions (including hurricane or cyclone), high or low water levels; (b) war, armed conflict, industrial dispute, civil strife, terrorist activity or the threat of such acts; epidemic, pandemic; (d) any new or change in law, order, decree, rule or regulation of any government authority (including travel advisories and restrictions).

### Force Majeure – Prior to travel

If in our reasonable opinion we (either directly or through our employees, contractors, suppliers or agents) consider that your travel arrangements cannot safely or lawfully proceed due to a Force Majeure Event then we at our discretion may elect to:

- reschedule your travel arrangements (in whole or in part); and/or
- cancel your travel arrangements (in whole or in part), in which case our contract with you will terminate (in whole or in part).

If we cancel any of your travel arrangements, neither of us will have any claim for damages against the other for the cancelled arrangements. However, we will refund payments attributable to the cancelled travel arrangements less: (a) unrecoverable third party costs and other expenses incurred by us for the cancelled travel arrangements; (b) overhead charges incurred by us relative to the price of the cancelled travel arrangements; and (c) fair compensation for work undertaken by us in relation to the cancelled travel arrangements until the time of cancellation and in connection with the processing of any refund.

### Force Majeure – During travel

If due to Force Majeure we cancel travel arrangements after your trip has commenced, we will provide you with a refund of recoverable third party costs for cancelled travel arrangements only.

### Force Majeure – General

## AMENDMENTS BY US

### Prior to travel

### During travel

You acknowledge that the itinerary, modes of transport, accommodation and/or the trip's inclusions may need to change during your trip due to local circumstances beyond our reasonable control, including road conditions, poor weather, changes in transport schedules, and/or vehicle breakdowns. You agree that we have the right to pass on any costs we incur for alternative arrangements we put in place for your benefit in these circumstances.

### General

To the fullest extent permitted by law, we will not be responsible for any omissions or modifications to the itinerary or the inclusions due to Force Majeure or other circumstances beyond or control happening after we have accepted your booking. This includes any loss of enjoyment or distress caused by omissions or modifications.

If you are entitled to any compensation for any modifications or omissions, then you agree it will be reduced by the value of any alternative services we provide which you accept.

We will not be responsible to you for any other expenses or loss you incur resulting from any amendment or change to the itinerary or its inclusions.

## UNUSED & DENIED SERVICES

No refunds will be made for any travel arrangements not utilised, whether by choice or because of late arrival or early departure. This includes the failure of transport to operate according to schedule, which we disclaim responsibility for.

If you are not fully and validly vaccinated against Covid-19 in the destination(s) where services are to be provided, and particular suppliers refuse to provide you with travel arrangements, then you agree you will not be entitled to any refund for those arrangements. We will not be responsible to you for any loss or expenses you incur (including loss of enjoyment or the costs of alternative arrangements) if you are denied services in these circumstances.

## CLIENT NAMES – EXACTLY AS PER PASSPORT

For security reasons, airlines and our overseas suppliers require names to be given exactly as stated in your passport. If you suffer from a medical condition which may reasonably be expected to increase your risk of needing medical attention, or which may affect the normal conduct of the trip, then you must advise us at the time you make your booking request.

We may request you to provide an assessment of your medical condition from a qualified medical practitioner. If the assessment indicates that you will require special assistance from personnel which we cannot reasonably provide, then we may cancel your booking. Provided you notified us of your medical condition at the time you made your booking request, we will provide you with a full of refund of payments made. If you fail to notify us at that time or if you fail to provide a medical assessment within a reasonable time of our request, then this will be considered a cancellation by you.

## ACCEPTANCE OF RISK

You acknowledge that travel involves personal risks which may be greater than those present in your everyday life. This could be as a result of the adventurous nature of your trip or the visiting of destinations which present geographical, political or cultural risks and dangers.

You should consult guidance issued by the Department of Foreign Affairs and Trade (DFAT) applicable to the destinations within your itinerary. ### Services supplied by independent suppliers

### Services we directly supply

To the extent only that we are the principal supplier to you of travel arrangements or other services which we control, then we will provide those travel arrangements and services with reasonable skill and care.

We will only be responsible for our employees in the course of their employment, and for our agents and suppliers (where we are not the supplier's agent or where the supplier is not an Independent Supplier) if they were carrying out the work we had asked them to do.
